1. Public Review Draft (PRD) Debrief:

- Executive Summary, Core Plan, Appendices are the key components.
 - i. ES is the same info as Core Plan just a more succinct way to introduce the plan, usually used for lawmakers, etc.
 - ii. Core Plan includes themes, goals, strategies, and action.
 - iii. Appendices = land use, background data, and outreach data.
- Sources that informed the draft not just community survey. Staff, public meetings, work group, spatial analysis, background documents, approved plans, and more!

5. Introduction Chapter: Comments by Working Group

- Project Area corrections and revisions: In the lower paragraph revise reference to local and regional Tribes.
- The Intro is helpful to frame the mindset for the reader and how the plan. Did an excellent job of what it represents and how important it is.

6. Land Use and Environment Chapter:

- Strategies order look good.
- Rely on the Tourism strategy for tourism areas "Implement the Tourism Strategy."
- Make sure development cost increases are discussed in floodplain and building code strategies/actions.

7. Housing Chapter:

- No references to tiny houses. It's popular topic especially with limited land availability.
 - i. Find available land is step 1; strategy 2 doesn't focus on tiny homes some developers had concerns about cost to develop, so focused on middle housing (duplex, triplex)
- I agree that tiny homes should be there, but there are no restrictions. The hurdle is homeowners' insurance.
- We may want to have a policy in the plan for multiple detached homes on one parcel. Code sometimes makes it harder.
- The Borough is having to grant several variances this needs to be cross referenced with both Land Use and Housing chapters.
- "Monitor" STRs. Suggest creating a permitting process for that. It will help with indicators and monitoring
- The city charges a lot for construction disposal. That could be addressed to help with "affordability."

8. Economic Development:

- Pleased to see some focus on workforce development, CTE, education.
- Strategy 1 suggest revising to support development that "may be identified in future documents like CEDS, including but not limited to."
- Under D KIC members now has a small business advisor and department that could be included in the list.
- Strategy 3: Skilled and Resilient workforce KIC has a CTE program and are one of the five pilot tribes doing a school compact with state/school districts/Tribes. That could be mentioned.
- Food Security Explore/Support of traditional subsistence Ketchikan is now a rural community and subsistence is now afforded to us. Subsistence food items helps with cost of living. It doesn't really come through in the Census but could be mentioned in the plan.

9. Cultural/Wellness/Education:

- Need guidelines for addressing opiate crises... would like to see a more comprehensive approach instead of piecing it out.
- Strategy 3, 4, 5 are nebulous. Sharli will email questions she had about vagueness.

10. Next Steps and Closing Thoughts

- Working Group to help with outreach
- PC Revisions / Amendment Process will inform the next draft (Public Hearing Draft).
- Great job on the plan!
